- Plans must be stamped by a licensed Civil Engineer.

Technical Reports, which can include:

- Storm Drainage Report per City of Walla Walla Stormwater Manual
- Soils Engineering Report
- Geotechnical Report

*Grading for a single property that is in an isolated, selfcontained area with no impact to public right-of-way or critical areas. Project must be less than 100cy, clearing less than 3/4 acre, and not need SEPA
