

# Introduction

The Infrastructure Repair and Replacement Plan (IRRP) has now completed its ninth year of construction. For those unfamiliar with the IRRP, this program was established by City Council in April 2010 to provide a systematic approach to replace the City's three failing critical infrastructure systems: water, sewer, and streets. Of the 160 miles of failing infrastructure systems in the City, there are 43 miles where the water, sewer and streets are failing in the same locations. The IRRP is focused on replacing the infrastructure in these areas. The program is funded by utility revenues at an annual rate of approximately \$5,000,000 per year. This annual progress report summarizes the achievements and costs of the previous years' work.

## 2018 Projects

In this past year, the City completed three IRRP projects which included: Wauna Vista Dr and Crestview Dr – from Hilbrooke Dr to Fern Ave Frazier Dr – from Mountain Park Dr to Hood Pl

Pine St and Cherry St – from 13<sup>th</sup> Ave to Irene St

The table below provides a summary of costs for the 2018 IRRP program year.

#### **2018 Quantitative Results**

The 2018 IRRP projects replaced a total of 150 water services. Many of those were found to be leaking water when they were exposed during construction. During replacement of the sanitary sewer, inspection observed multiple areas of prolonged sewer leaks under the roadway. This was attributable to deteriorated pipes and joint separation. The elimination of both the water leaks and sewage exfiltration under the roadway will not only protect the roadway and soils underneath, but will also reduce overall water loss. Along with the 8,756 linear feet of sewer main replaced, 154 sewer services were also replaced.

## 2019 Projects

In 2019, the IRRP Program will complete two projects that currently have utility and roadway failures associated with them.

- The Tietan & Sunset IRRP project has project limits that extend from 4<sup>th</sup>
  Ave. to Modoc Street on Tietan, from Lodge Drive to Tietan Street on
  Sunset Street, from Winnebago Street to Milburn Street on S. 3<sup>rd</sup>
  Avenue, and Elliott Place. Total project cost is estimated at \$2,523,000.
- The Isaacs Avenue (Phase II) IRRP project has project limits from
  Division Street to Wilbur Avenue. Total project cost is estimated at
  \$8,575,000. Funding for this project includes successful outside grant
  support from several state and federal sources totaling \$5,112,000.
