#### ANNUAL REPORT

This Annual Report is prepared in accordance with the Walla Walla City Transportation Benefit District (TBD) requirements as provided in the City of Walla Walla Municipal Code 2.60.020(D) and RCW 36.73.160(2), "A district shall issue an annual report, indicating the status of transportation improvement costs, transportation improvement expenditures, revenues, and construction schedules, to the public and to newspapers of record in the district."

#### ANNUAL WORK PLAN

This Annual Work Plan is prepared in accordance with the TBD as provided in RCW Chapter 36.73, in the City of Walla Walla Ordinance 2011-19 and its Bylaws, and by the Interlocal Agreement between the City of Walla Walla and the TBD, "Develop an annual work plan and designate construction, reconstruction, street maintenance, and preservation projects within Walla Walla for funding."

#### 2013 Annual Work Plan

Last summer the TBD Board adopted the City's 6-year Transportation Improvement Plan, which showed Rose Street as the inaugural Transportation Benefit District project. The rehabilitation of Rose Street will be the full focus of TBD construction for 2013. In an administrative roll, the TBD will establish a six-year plan and begin planning for construction of the remaining portion of Rose Street and Wilbur Avenue (between Whitman Street and Pleasant Street) for construction 2014.

In November of 2012, the City's Engineering Division was notified of selection for award of a \$200,000 Pavement Preservation Grant from the Washington State Transportation Improvement Board. Even with this grant adding to the City's 0.2% sales tax revenue, rehabilitating Rose Street from 2<sup>nd</sup> Avenue to Carrie Court at the City limits with College Place, exceeds TBD's first year resources, and Rose Street is being undertaken as a multiyear project. The desired goal for construction in 2013 is to improve Rose Street from the railroad tracks near 13<sup>th</sup> Avenue to Carrie Court. This section presents significant challenges that may require the project limit to be reduced to match the available funding.

- Duval Engineering is nearing completion of their pavement evaluation effort of Rose Street. In January they will issue their final report identifying through a life cycle cost analysis, the most cost effective rehabilitation strategies.
- Anderson Perry & Associates (AP) is currently conducting survey work. They will soon begin taking Duval's report and implementing it into plans and specifications for construction.
- The biggest challenge for 2013 is obtaining property for the required American Disabilities Act sidewalk improvements at intersections (Section 35.151 of 28 CFR Part 35), in a timely manner. This will be conducted by Universal Field Services, a sub consultant to AP, on an extremely aggressive timeline.
- The current schedule shows completion of the 2013 design in April, advertisement for bid in May, contract award and start of construction in July and completion in October.
- Planning for the remaining portion of Rose Street and Wilbur Avenue will begin in the summer/fall of 2014.
