WHEREAS, the undersigned has requested that City of Walla Walla employees enter onto private
property at,
to deliver and service a sanitation drop box.
NOW, THEREFORE, the undersigned does hereby agree to indemnify and save harmless the CITY OF WALLA WALLA, a municipal corporation, its agents, servants, employees, and officials, from any and all liability or claims for damage arising out of the utilization of the City's sanitation drop box service, and do further agree to defend and pay the expenses of defending any actions which may be commenced against the City of Walla Walla, its agents, servants, employees or officials by any person or entity alleging any injury or damage arising out of the placement of the sanitation drop box on either public right-of-way or private property. I further understand that placing this container close to buildings and on soft ground will cause the drop box to load unevenly and may cause damage to the building. I will hold harmless the City of Walla Walla from any and all liability or claims for damage arising from having the container placed closer to the building than the allowed four feet and/or not on hard asphalt/concrete service, except for the negligent acts or omissions of the City or its employees. I also acknowledge that I have received a copy of the Drop Box Service Fees.

2022 Temporary Drop Box Fees

Drop box fee list (roll-off containers):

\$ 1,000.00	Deposit (per container)
\$ 129.60	Delivery fee
\$ 129.40	Service fee (per haul) *
\$ 221.00	Monthly rental for a 10-yard container
\$ 283.20	Monthly rental for a 20-yard container
\$ 339.50	Monthly rental for a 30-yard container
\$ 99.20	Landfill tonnage fee – billed separately

^{*}The \$1,000.00 deposit is applied to 2 separate billing accounts. The first is a "utility" account that includes the fees for the delivery, hauls to landfill, and monthly rental. The second is an invoice that will be sent and this will contain the weight charges at the landfill.

<u>Example</u> – rental of a 20-yard drop box for 10 days, emptied two times, with two tons in the box each time (for a total of four tons of debris):

\$ <i>129.60</i>	Delivery of drop box to the site
\$ 258.80	Service fees for emptying the box 2 times at \$129.40 per haul
\$ 94.40	Rental for ten days at \$9.44 (approx.) per day
\$ <i>17.38</i>	Washington State Refuse Tax (3.6%)
\$ 500.18	Subtotal
\$ <i>396.80</i>	Landfill tonnage fee (4 tons at \$99.20/ton)
\$ 896.98	Total drop box service and tonnage fees

Additional charges may be assessed to the bill for blocked containers, container relocation, for containers that are not properly prepared to be emptied (e.g. lid not down, door not closed), and for damage to containers (e.g. containers loaded with concrete, rock, construction debris, or debris overloading the box).

Please schedule requests at least one business day in advance. Same day requests will be accommodated, if possible. Please call to schedule at least one business day in advance.

^{*}This fee applies whether the box is emptied and returned to the job site or emptied and removed.

^{*}There is a minimum two-week service requirement. The drop box must be serviced at least once every two weeks or the service fee will be assessed.
